How often should I perform biological monitoring?

CDC and AAMI guidelines recommend biological testing should be performed at least weekly for each sterilizer to ensure proper functioning.

In addition to weekly monitoring, practices should perform biological monitoring:

- \checkmark Whenever a new type of packaging material or tray is used
- After training new sterilization personnel
- ✓ After any sterilizer repair or maintenance
- After any change in the sterilizer loading process
 - EVERY DAY: SteamPlus" Integrating Indicator Use a check mark to indicate daily testing with a integrating Integrator. When the dark bar enters the SAFE zone, non-implant loads can be released while waiting for the biological monitoring results.
 - P EVERY WEEK: ConFirm[®] Mail-in or In-Office Biological Monitoring System Indicate Pass (P), Fail (F) or Invalid (I). Also indicate mail-in (M) or in-office (O) biological monitoring type.
